QUEENS CIVIC CONGRESS TO CITY HALL: PROVIDE FLOOD RELIEF

In testimony submitted to the City Council Committee on Environmental Protection, chaired by Queens Councilman James Gennaro, on "Oversight - Rising Waters: What Can the DEP Do About Flooding?" today (Monday, September 24, 2007) at City Hall, Queens Civic Congress Vice President Dorothy L. Woo outlined sensible actions the City can implement without reliance of more exorbitant capital projects:

Testimony to the City Council Committee on Environmental Protection Oversight - Rising Waters: What Can the DEP Do About Flooding? September 24, 2007

Thank you Chairman Gennaro for this opportunity to share concerns of Queens residents at this oversight hearin,"What Can the DEP Do About Flooding?" I am Dorothy L. Woo, Vice President of the Queens Civic Congress, and chair of its Infrastructure Committee. As a coalition of 100 civic, community, condo, co-operative, homeowner and tenant organizations, the Queens Civic Congress membership represents almost every community in the borough.

The Queens Civic Congress appreciates FEMA's relief program to assist homeowners and small business to recover from rainstorms damage on August 8 and July 18. Unfortunately, we find this program and the city response insufficient and impractical to resolve the chronic and severe flooding problem faced by Queens (and city) residents. No question, "man-made" mistakes more than rain contributed to the flooding disaster.

Queens residents – by and large proud hard working middle class people – choose to live here to raise our family. Residents demand more than handouts or onetime relief from FEMA which come with the requirement to reveal personal financial backgrounds in order to qualify for grants or loans. Queens residents demand a reliable sewer system free from water backup or seepage to our basements and in many cases the main floors of homes, apartments and businesses. After all, water bills include a rather significant wastewater service charge.

City agencies bear responsibility for disaster prevention now and in future. Therefore, Queens Civic Congress recommends:

✓ Installation of water prevention devices (free of charge) in homes which experience chronically sewer backup during heavy rains.

- Immediate enforcement of existing Zoning Resolution and Building Code requirements on properties with illegally paved front yards.
- ✓ Regular -- and frequent -- catch basin cleaning every six months.
- Environmental impact review that impose any need for a flood plan before new construction and zoning map changes take affect.
- ✓ Elimination of real estate tax abatement in exchange for sewer improvements for any new construction where the floor area ratio (FAR) exceeds than the previous structure.
