## **President's Message**

Welcome back from as we move from summer to a beautiful Autumn as we commence our 2008-09 year at the Queen County Farm Museum. Once again, Queens Civic Congress plans an ambitouus program from updating our dynamic CIVIC2030 platform to a series of forums on important issues, from informal conversations with those who seek to lead our borough and city in 2010 (election next year) to a May forum that we expect to feature all those who wish to be our Mayor.

Congratulations Parkway Village residents who prevailed against JP Morgan Chase which had refused to allow financing the development needs to improvement its heating system. The Juniper Park Civic Association (JPCA) pulled one out for the civic movement with a victory over notorious developer (best known for destroying the landmarked RKO Keith in Flushing) who illegally constructed a house at 57-39 Mazeau Street in Maspeth in 2006. The NYC Buildings Department determined the house was built contrary to its approved plans and in violation of the community's R4-1 zoning. The developer removed the top story and a section on the side of the house that encroached on the lot next door. At that time I stated: Queens Civic Congress calls on all would-be violators of the City's Zoning laws and its Building code to be on notice. No excuses. Either comply with the law and the code or any illegal structure you build will need to be cut down to its rightful and legal size. This simple message should resonate throughout the industry.

We need to continue our focus on our beautiful nabes. As EVP Patricia Dolan wrote in the NY Times this summer, "Queens's residential neighborhoods are still caught up in a building boom whose major accomplishment seems to be tearing down older homes and replacing them with the behemoths described in your article. While the new houses may be legal, paving over every square inch of open space and walling in the product to create a fortress is not. Residents of these neighborhoods have been fighting for a minor change in a zoning resolution that would save these graceful older neighborhoods – but the Department of City Planning has been too busy accommodating developers whose plans are closer to the mayor's vision of an evergrowing city than the aspirations of longtime homeowners in Queens."

Queens Civic Congress welcomed a May 13 reply from City Planning Chair Amanda Burden, the first response in at least three years to numerous letters from our members regarding needed neighborhood rezonings and new districts. While Queens communities welcomed an acceleration of protective initiatives in 2005, and the commencement of ULURP on rezonings noted in Planning Chair Burden's letter (Dutch Kills, The Rockaways, Waldheim and Laurelton), the pace of these efforts took a considerable backseat to development projects that consume many of the staff and other resources needed to continue the efforts that ceased since late 2005. We shared this view with the Mayor: urging City Hall "to accelerate protective efforts to preserve under-and unprotected Queens neighborhoods."

Too many Planning Department actions to date suggest that City Hall lacks information it ought to be provided. Queens rezonings did not just happen. Queens Civic Congress, its predecessor organizations and its member organizations have advocated for specific neighborhoods for more than two decades. The first occurred under then Borough President Shulman during the Koch Administration; another 25 came about during the Giuliani administration. While City Planning Department continues at its current slower than a snail's pace, too many blocks in too many neighborhoods get overbuilt into "non-conformance." The Koch administration created low density contextual zones in less than six months; no reasonable explanation exists why this administration resists these clearly needed zoning reforms: "One Family Narrow Lot", "One Family Row House" and "R1A".

# **Queens Civic Congress Position on** *Term Limits*

# Approved by the Executive Committee for Consideration by the Membership Monday, September 15, 2008

- 1. Queens Civic Congress representing the civic movement in the borough of Queens calls on ALL public officials and those who aspire to public office to commit to the use of referendum to attempt any change in the City Charter enacted in that matter, and state that position publicly.
- 2. The public voted two separate times, first to enact term limits and second to reject its repeal. Consistent with this position, any change in term limits, from revocation to extending or reducing the number of terms must only be enacted by the same process of voter referendum that enacted the two-term limits on municipal office holder.
- 3. Queens Civic Congress takes no position on the substance of term limits; some in the civic movement support term limits; some oppose it; others support it for some offices but not all. Queens Civic Congress says "let the voters decide."
- 4. Simply put, Queens Civic Congress opposes any plan to change the term limit law as currently exists except through a public referendum.
- 5. If City Hall and the City Council seek to repeal or modify terms limits, anything other than a voter referendum smacks of illegitimacy.

\*\*\*\*In light of the public discussion about changing term limits for City elected officials (Mayor, Public Advocate, Comptroller, Borough President, City Council Member), members of the civic movement sought out the position of Queens Civic Congress. Our CIVIC2030 and prior platforms did not speak to the issue. We researched our public statements and meeting minutes and found no position. There may have been positions by our predecessor regional civic councils that merged to create Queens Civic Congress more than a decade ago. (As you may recall the public referendums enacting term limits occurred before the civic movement founded Queens Civic Congress.) The Executive Committee recommends the five point position to the membership. Queens Civic Congress will publicize the adopted position statement, including on our www.queensciviccongress.org website.\*\*\*\*

### **Nominating Committee Report**

The QCC Officer Nominating Committee was elected in June. According to our bylaws, The officers are: President, Executive Vice President, Vice Presidents (no less than one and no more than eleven, as determined by the Congress), a Treasurer, a Secretary, and the two Founders. All officers sit and vote as members of the Executive Committee. Save for the Founders, all officers shall serve one-year terms. CC's Nominating Committee consists of <u>five</u> persons, of which three shall be elected by the Executive Committee (including its Chair) and two by the Regular Members.

The Committee recommended the membership re-elect our current team of officers Anyone nominated must be a delegate representing a Regular Member to the Congress. Candidates for President must have served on the Executive Committee in the year prior to their nomination. If no nominations occur from the floor, nominations will be closed and the secretary will cast one ballot for their election.
