# **Queens Civic Congress Position on** *Term Limits*

### Approved by the Membership Monday, September 15, 2008

- 1. Queens Civic Congress representing the civic movement in the borough of Queens calls on ALL public officials and those who aspire to public office to commit to the use of referendum to attempt any change in the City Charter enacted in that matter, and state that position publicly.
- 2. The public voted two separate times, first to enact term limits and second to reject its repeal. Consistent with this position, any change in term limits, from revocation to extending or reducing the number of terms must only be enacted by the same process of voter referendum that enacted the two-term limits on municipal office holder.
- 3. Queens Civic Congress takes no position on the substance of term limits; some in the civic movement support term limits; some oppose it; others support it for some offices but not all. Queens Civic Congress says "let the voters decide."
- 4. Simply put, Queens Civic Congress opposes any plan to change the term limit law as currently exists except through a public referendum.
- 5. If City Hall and the City Council seek to repeal or modify terms limits, anything other than a voter referendum smacks of illegitimacy.

Dear Mr. Mayor:

On behalf of Queens Civic Congress, I write to oppose any real property tax gouge and propose a sound and practical alternative. Your administration can make a real difference by reforming the real property tax system to re-introduce equity and fairness into the system as proposed by Queens Civic Congress. Hiking property taxes across the board – makes no sense.

Queens Civic Congress – in testimonies, statements, other advocacy and, most recently, our "<u>REAL</u> Property Tax Reform" forum – advocates an <u>improvement</u> that bring equity, fairness and transparency to the City's antiquated, inequitable and unfair real estate tax regime AND nets the City some five billion dollars – yes, \$5,000,000,000, without gouging middle and working class homeowners, businesses and tenants. <u>CIVIC2030</u> includes this and other Queens Civic Congress reforms.

Queens Civic Congress advocates most of the net revenues, not for the city the embark on a spending spree, but to help it strategically reform its tax system, address long-term borrowing issues and re-structure its out of whack budget. ### COALITION FIGHTING ESCALATING NYC WATER & SEWER RATES

Queens Civic Congress (QCC) and the Croton Watershed Clean Water Coalition, Inc. (CWCWC) with over 50 NYC, Westchester and Putnam counties environmental, citizen activist, housing and religious member groups have united to outreach to other concerned groups and NYC Community Boards in an alliance to halt the unsustainable, escalating NYC water and sewer rates. The CWCWC presentation at the October 6 QCC meeting will cover many of the reforms sought, including

- Either secure immediate federal and state aid to fund the mandated capital improvements;
- Or the NYC capital budget must fund the capital costs for water supply and treatment facilities;
- Cease the practice of setting rates before the City adopts its budget by passing legislation <a href="http://assembly.state.ny.us/leg/?bn=A04824">http://assembly.state.ny.us/leg/?bn=A04824</a> sponsored by Assembly Member Mark Weprin that has already passed the Assembly and is pending in the Senate. The Independent Budget Office's May 2008 brief identifies costs that can be reduced or are wrongly charged against the water rates: higher fringe benefits accounting (\$19 million), debt service savings (\$17 million) from delays to non-essential projects and holding code 499 (\$94 million);
- Eliminate annual rental payments by the City to its Water Board, currently \$178 million and expected to increase further, to the City and return the current payment of \$147 million;
- Discontinue using water taxes for projects unrelated to water and sewer needs that instead should be funded from the regular budget (\$15 million a year).
- The Croton project funds projects outside the scope of water supply and sewer systems that should be funded by City capital: These parks projects should be funded by tax levy and not the regressive water and sewer tax;
- Investigate NYCDEP's quadruple increase of the Croton filtration plant cost estimates
- Replace NYCDEP's misguided choice of obsolete Dissolved Air Flotation technology for the Croton Watershed filtration plant with modern Membrane filtration today's technology of choice for less cost, less energy consumption and smaller footprint;
- Force NYCDEP to remedy the ongoing waste of over a million gallons a day of groundwater at the Croton filtration plant site;
- Invest in more land purchases and conservation easements in the Croton Watershed for the most costeffective way to protect the source water of the Bronx and Manhattan water supplies. The more the water is allowed to degrade by pollution from over-development, the greater the cost of remediation;
- Scrutinize the complete list of neglected and necessary infrastructure repair costs including the Delaware leak;
- Improve NYCDEP's obligation to keep existing storm and combined sanitary-storm systems in a state of good repair to prevent recurrences of summer 2007 backups into Queens' homes and apartments;
- Support efforts to ease impacts of high water rates on senior homeowners and tenants by passing legislation <a href="http://assembly.state.ny.us/leg/?bn=A07961">http://assembly.state.ny.us/leg/?bn=A07961</a> which would provide a tax levy subsidy to households 65 or older and with incomes below current Senior Citizens Homeowner Exemption eligibility limit;
- Improve water and sewer billing policies.

By continuing to build our coalition and with growing public awareness and concern, we foresee our issues being considered and acted upon. Water, our most precious resource without which we cannot survive, must be protected. In addition, our ability to afford clean and safe water is a #1 priority.
