# Land Use Forum 2009

## Monday, March 30, 7:00 p.m. Kew Gardens Community Center, 80-02 Kew Gardens Road \* New R1-2A Text \* \* Getting More Nabes Re-Zoned and/ or Landmarked \*

Last year<sup>1</sup> almost 100 Queens civic leaders met for QCC's inaugural land use forum. The 2008 forum addressed landmarking and historic preservation in Queens.

This year QCC is broadening our scope to underscore the role of zoning in neighborhood preservation--and stabilization. We plan a review of 2008's neighborhood rezonings and a discussion on zoning priorities for 2009. The 2009 forum will include a presentation of the new R1-2A zone, which the Department of City Planning certified on January 20. The rezoning of North Flushing, which is now in ULURP includes areas to be zoned R1-2A.

We will take up the Mayor's promise--in his State of the City address--that Ridgewood will be calendared for landmarking in 2009 and that other Queens neighborhoods will be examined in 2009. We will also hear from neighborhoods that are clamoring for landmarking--including Richmond Hill, parts of Southeast Queens, Jackson Heights (extension), East Elmhurst and Broadway Flushing.

This year's QCC land use event will be held at the Kew Gardens Community Center, 80-02 Kew Gardens Road--just steps from the Union Turnpike E and F subway station. There is parking on the street and nearby in the Borough Hall.

QCC Landmarks Chair Paul Graziano, a neighborhood resident, President of Historic Districts Council and professional planning consultant, provided all of the documentation and testimony needed for Broadway-Flushing to obtain their Federal and State Historic District status about two years ago.

It seems that the NYC Landmarks Preservation Commission finds it difficult to see the value in residential communities in the Boroughs other than Manhattan.

This is not the end for Broadway-Flushing but the beginning of their fight for landmarked status.

#### QUEENS CIVIC CONGRESS WELCOMES DOB DELAY IN RULES CUTTING PUBLIC REVIEW OF PROJECTS & DEVELOPMENT

Queens Civic Congress welcomes the NYC Department of Buildings (DOB) delay in proceeding with changes to its system for the public to make building complaints. Following the issues raised by Queens Civic Congress, elected officials including Queens Council Member Tony Avella, Brooklyn Council Member Bill deBlasio and Comptroller William Thompson, and civic advocates from throughout the city, including our partners at the Historic Districts Council, the Greenwich Village Society for Historic Preservation and the Municipal Arts Society, the DOB announced that "the launch date for the new process will be moved to mid-April." As the umbrella group of 110 and growing civic organizations, with a membership that represents every community in the borough, Queens Civic Congress welcomes this additional period to allow the Department of Buildings (DOB) to address clear flaws in the process.

In a letter commending Commissioner Robert LiMandri for putting the rules off, Queens Civic Congress noted that the DOB lacks any authority to limit the reporting of illegal activity. In fact, the proposal, if adopted unchanged, clearly creates an immunity for the building community when civics, community members and others with standing challenge in court any dismissal of their examining a complaint. Queens Civic Congress strongly recommends the DOB reform the propose changes to avoid what must be an unintended consequence – that would perpetuate illegal and often hazardous development.

Why risk effectively development activity that fail to follow plans that may be legitimate but the illegality gets exposed after the passage of thirty days? [continued bottom, page 7]

Many illegal condition may not be visible even subsequent to the substantial completion, again after the 30 days are tolled. In addition, concerns remain about the general inability of the DOB to respond timely to inquiries or make files available. A short complaint period thereby delays any reasonable attempt to conduct a due diligence prior to filing a complaint.

As stated in its testimony, Queens Civic Congress generally opposes any statute of limitation type prohibition on complaints beyond the 30 day process outlined in the proposed rules.

Queens Civic Congress looks forward to continuing its dialogue with the DOB and looks forward to Commissioner LiMandri's participation in the April 20 Queens Civic Congress membership meeting as a good opportunity to further explore areas for attention and reform.
