#### **President's Message**

Dear Members.

The City posted a <u>survey</u> that aims at a "review" of the environmental process. You have only through May 22 so please act soon. Since the administration maintains a *de facto* – by its deed – commitment to gutting community boards Queens Civic Congress strongly urges its members and friends to respond to the <u>survey</u> (see link paragraph four below).

<u>CIVIC 2030</u>, our platform, not only recognizes the important role of our community board, but recommends the city adequately resource these local boards of citizen-volunteers each staffed by small team of caring pros who know how the city works. City Hall again cut the budgets for the board. I would certainly sacrifice a Deputy Mayor or two before I would let such dumb cuts get done.

In the meantime, please speak out for community boards and the need to staff them adequately as part of any response you make to the planning <u>questionnaire</u>. My personal <u>experience</u> with community planning now approaching three decades including two of them in city government with the City Council and a borough president (including oversight of the agency's planning functions) found more problems with the process BEFORE projects and proposals came to the community board.

City Hall invites comments: We are looking for input from all users of the environmental review process--including applicants, developers, community members and groups, consulting firms, agencies, community boards, and elected officials--on your experience with the City's management of the environmental review process. Parties who have participated in environmental review are encouraged to submit their opinions, views and recommendations about how City agencies can better manage the environmental review process. So please take them up on it at: http://www.nyc.gov/html/misc/html/2009/environmental\_questionnaire.html

Thank you to Community Board 13Q Chair and Queens Civic Congress Vice President Rich Hellenbrecht who first brought the issue to my attention. Rich is reaching out to his fellow chairs to urge they respond to the survey.
