Dear Members.

A June 8 email from City Hall promoted a "pilot" *Development Coordinator Initiative* program launched June 1 in Brooklyn "to resolve specific interagency conflicts that may be slowing down development." The City bills it as a "new resource for developers, contractors, and licensed professionals. I certainly found it "interesting" to receive such an email on the eve of a June 9 City Hall rally to press the Mayor to restore cuts to community boards which the City Charter empowers to weigh in on service delivery and land use. My open question to City Hall and those running for City office: Why not a *Preservation Coordinator* to address zoning, building and landmarking issues. Note to candidates: You need only go to our website to view or platforms, our meetings and our media posts which include statements, testimonies and comments. Any failure to do raises questions if a candidate seriously maintains an interest in civic and community issues. Nominating Committee

The QCC Officer Nominating Committee will be elected in June. According to our bylaws, The officers are: President, Executive Vice President, Vice Presidents (no less than one and no more than eleven, as determined by the Congress), a Treasurer, a Secretary, and the three Founders, including the President-Emeritus. All officers sit and vote as members of the Executive Committee. Save for the Founders, all officers shall serve one-year terms. QCC's Nominating Committee consists of <u>five</u> persons, of which three shall be elected by the Executive Committee (including its Chair) and two by the Regular Members.

The Committee shall prepare a list of nominees for the election of officers and send by regular mail its report on or before July 1 to the Executive Committee and Regular Membership. Nominating Petitions for the candidacies of persons not nominated by the Nominating Committee may be submitted to the Chair of the Nominating Committee with the signatures of 15% of the Regular Members no earlier than July 15 and no later than August 15. Anyone nominated must be a delegate representing a Regular Member to the Congress. Candidates for President must have served on the Executive Committee in the year prior to their nomination. The election is planned for next fall.
