Dear Members,

On October 9, candidates running for City Council, Borough President, City Comptroller, Public Advocate and Mayor received the 2009 Queens Civic Congress Candidates Survey (See page 4 for the survey questions.). Candidates were asked to submit their responses as soon as possible and were promised that responses would be posted on our website as soon as practicable after receipt. Queens Civic Congress also advised candidates that, starting October 23, we will also post a list of candidates and whether or not they responded to the survey and link the responses to each survey. The responses will also be shared with the News media and our member organizations - you. Find the candidate responses received to date at our website's *Platform* link (See: <u>http://queensciviccongress.org/platform/index.php</u>); this includes a separate list of all elected officials and candidates who indicate their support for our CIVIC 2030 Also the first link in our Media section through election day includes links to all platform. http://queensciviccongress.org/Media/files/2009/2009-11candidate responses (See: 03 Responses.pdf.). Special Thanks to Executive Vice President Patricia Dolan and Secretary Sey Schwartz for pulling this special project together after a discussion at our September board member.

Thank you also to QCC's Park co-Chair Kim Ohanian who arranged for our meeting space in the beautiful Al Oerter Rec. Center on the eastern perimeter of Flushing Meadows Corona Park. We used it for Going Green in Queens last Spring, a candidates forum and our September board meeting.

Queens legislators led by Asembly Member Rory Lancman and Senator Shirley Huntley developed and passed legislation that would require a public hearing within 30 days of notice of a hospital's plans to close, or of its involuntary closure. It very simply would empower the NYS Department of Health (DOH) to reassure our fellow citizens of what steps DOH will take to insure that adequate health and hospital care resources for affected communities remain in place. Unfortunately, the Governor disappointingly vetoed this sound legislation.

We continue to work with our members on candidates forum to make sure candidates address civic concerns and issues. New Yorkers for Parks and Historic Districts Council's League of Preservation Voters (LPV) sponsored many of the forums. Queens Civic Congress participates in NY4P's Parks 2009 and LPV's efforts to survey candidates.
